As of 7th June, 2022, GOtek.my compares Motor Takaful Contributions which the Gross/Basic Contribution stated in the quotations is provided by Syarikat Takaful Malaysia Am Berhad, Takaful Ikhlas General Berhad, Etiqa General Takaful Berhad and Zurich General Takaful Malaysia Berhad via their agency quotation systems.

#### **Definitions**

"service provider" means the Takaful Agents or Representatives who provide the motor Takaful quotations on our portal.

"website" means any website, mobile website, portal, mobile application

"you" and "your" means the person who accesses and uses our website.

# **Acceptance of these Terms and Privacy Policy**

The failure to renew your road tax may require you to cancel your Takaful Certificate and it involves refund processes of which the Refund clause will apply.
